The document will be obtained personally and with an application letter. Tenderers are advised to use the **address** stated below for obtaining information, inspection and purchase of Tender Document.
4. Tenders must be deposited into the box located at **address below** on or before 10:00 hours GMT on Monday, 29th August, 2022. Tenders shall be valid for **180 days** after the deadline of Tender submission. All Tenders must be accompanied by a Tender security stated in the table above for the package.

5. Late tenders will be rejected. Tenders will be opened in the presence of the Tenderers or their representative, who choose to attend at the District Assembly Conference Hall of Afigya Kwabre North District at 10:00 hours GMT on Monday, 29th August, 2022.
